

# General Information

## **Discount:**

A \$5 discount for campers completely registered before December 2nd.

## **Late fee:**

A \$5 additional charge will be assessed for registrations received within 7 days of the start of the retreat.

## **Arrival:**

Registration is Friday from 5:30 –6:45PM. Retreats begin at 7:00 PM with a snack.

## **Delayed Arrival:**

If your arrival is delayed and you will arrive after the start of the retreat, please call the camp office at 973-293-3522.

## **Departure:**

Retreat ends after dinner on Saturday at 6:00 PM.

## **Sponsors:**

Churches are asked to bring one sponsor for every 8-10 campers. Sponsors will be housed in the cabins with the campers. One sponsor may attend free for every 8 campers registered. Sponsors should also register.

## **Please Bring**

Bible, bedding, pillow, towels, toiletries, some clothing and shoes you don't mind getting a little dirty, camera and spending money for the snack shack and bookstore.

## **Please DO NOT Bring**

Tobacco products, alcoholic beverages, illegal drugs, fireworks, guns, ammunition, knives,

weapons, radios, CD/mp3 player, ipod, TV's, video games, cell phones, magazines, skateboards, scooters, roller blades, playing cards, magazines or clothing with worldly advertising.

## **Dress Standards**

Ladies may wear slacks, jeans that are not tight, culottes, or knee-length shorts. Low-cut necklines, sheer blouses and tight-fitting tops are not permitted.

Men may wear jeans or knee-length shorts. No tank tops are permitted.
